- Draw status information will be available 10 days after the draw.
 - Visit ngpc-permits.ne.gov/NGPC-PS/faces/public/welcome and click "Check Draw Application Status."
 - Provide last name, date of birth and last four digits of social security number.
 - Successful applicants may print their permit. Applicants who do not print their permits will receive their permits in the mail in late June or early July.
 - Landowner applicants are encouraged to go online early and enter their legal descriptions. Parcel identification numbers are no longer acceptable.
 - Online enrollment assistance is available from our district offices.
