THIS APPLICATION UPON APPROVAL WILL CONSTITUTE A VALID PERMIT TO TAKE FISH FROM PRIVATELY OWNED WATERBODIES DURING THE CALENDAR YEAR AND BY METHODS AND MEANS SPECIFIED ABOVE.

Only registered sampling equipment can be used and approved nets shall be tagged with tags supplied by Fisheries Division, Nebraska Game and Parks Commission. Any changes to the original application form (i.e. employee change, lost/stolen or newly purchased equipment, etc.) shall be reported within 72 hours. A Commercial Fishing Permit is required to sell removed nongame fish and bullheads. A copy of the approved application must be in possession when conducting permitted activities. The area conservation officer, district law enforcement supervisor, or if the officer and supervisor are unavailable the Law Enforcement Division headquarters shall be notified at least 24 hours prior to permitted activities.
