# Application for Special Occasion Permit

### 1. HOW TO APPLY

- A. Discuss your plans with the Area Superintendent.
- B. Review and complete this application and forward it to the Area Superintendent or to the Nebraska Game and Parks Commission at the above address at least **30 days prior** to the scheduled event.

### 2. TERMS AND CONDITIONS

- A. The Permittee agrees to obey all applicable laws, rules and regulations promulgated by the State of Nebraska and any Agency thereof or by the United States or any agency thereof.
- B. The Superintendent will designate the area for the Special Occasion use, and such use will be confined to that area. The permit does not grant exclusive use of the area. The Commission or its representatives reserve the right to enter the permit area for purposes required by their responsibilities, including viewing of the special occasion.
- C. The Permittee agrees to hold harmless the Nebraska Game and Parks Commission and/or its representatives from any injury or liability arising from activities authorized by this permit. Liability insurance with the State of Nebraska named as co-insured and/or the execution of a separate individual "Hold Harmless Agreement" may be required for certain activities.
- D. This Special Occasion Permit may be canceled or revoked at any time by the Commission upon violation of area regulations or for other just cause.
- E. As a condition of the permit issuance, the Commission may require the filing of a bond with satisfactory surety payable to the State of Nebraska to cover costs, such as restoration, rehabilitation and clean-up of the area used, and other costs resulting from the Permittee's activity. In lieu of a bond, a Permittee may elect to deposit cash equal to the amount of the required bond.
- F. A valid Nebraska State Park Entry Permit is required for all vehicles entering any Nebraska state park, state recreation area or historical park, except those vehicles specifically exempted by law.
