

## SPECIAL LANDOWNER DEER PERMIT APPLICATION INFORMATION

33-384SLOA-8Permits/5-24-2022

Qualifying Landowners (QL) are eligible for up to eight (8) permits valid for the Saturday to Monday immediately preceding the November Firearm season to be designated to the Qualifying Landowner or members of their immediate family. Please read the following rules and complete the application. Only weapons legal for archery and firearm seasons may be used.

### Permit Requirements and Stipulations:

- Limit of one special landowner permit per individual.
- No more than **six** permits may be issued to individuals younger than 19.
- No more than **two** permits may be issued to individuals 19 or older.
- Permits are valid only on land listed under the qualifying landowner.
- Resident qualifying landowners must own or lease at least 80 acres. No more than one permit per 80 acres. (E.g. 240 acres = 3 permits).
- Nonresident qualifying landowners must own at least 320 acres. No more than one permit per 320 acres. (E.g. 960 acres = 3 permits).
- Residency of Qualifying Landowner determines acreage minimums and eligibility regardless of applicant residency.
- A partnership, corporation, or trust may designate one partner, officer, shareholder, or beneficiary as the Qualifying Landowner for lands owned by such entities.
- Permit cost is \$8 per permit (\$5 permit fee plus \$3 issue fee included). Applicant may pay for all 8 permits with one method.
- **All permits must be issued at the same time.**

**Immediate Family of Qualifying Landowner Definition:** “the spouse of such person, any child or stepchild of such person or of the spouse of such person, any spouse of any such child or stepchild, any grandchild or step-grandchild of such person or of the spouse of such person, any spouse of such grandchild or step-grandchild, any sibling of such person sharing ownership in the property, and any spouse of any such sibling.”

**Qualifying Property:** All lands must be listed as a part of the application process. Please use table on page 4 to list or print list from Qualifying Landowner’s permit profile. Make copies of page 4 if additional room is needed.

### Nebraska Revised Statute 37-455

(4)(a) In addition to any limited permit to hunt deer issued to a qualifying landowner under subsection (3) of this section, the commission shall issue up to eight limited permits to hunt deer during the three days of Saturday through Monday immediately preceding the opening day of firearm deer hunting season to any qualifying landowner meeting the requirements of subdivision (b) of this subsection and designated members of his or her immediate family. The fee for each permit issued under this subsection shall be five dollars. Permits shall be issued subject to the following:

- (i) No more than eight permits may be issued per qualifying landowner to the landowner or designated members of his or her immediate family, except that no more than one permit shall be issued per person for the qualifying landowner or any designated member of his or her immediate family;
- (ii) Of the eight permits that may be issued, no more than six permits may be issued to persons who are younger than nineteen years of age and no more than two permits may be issued to persons who are nineteen years of age or older; and
- (iii) For a Nebraska resident landowner, the number of permits issued shall not exceed the total acreage of the farm or ranch divided by eighty, and for a nonresident landowner, the number of permits issued shall not exceed the total acreage of the farm or ranch divided by three hundred twenty.

(b) For purposes of this subsection, the qualifying criteria for a Nebraska resident described in subdivisions (3)(a)(i) and (ii) of this section and the ownership criteria for a nonresident of Nebraska described in subdivision (3)(b) of this section apply.
