Aquatic Vegetation Control

Aquatic Vegetation - Submergent and Emergent

Although submergent (rooted at the bottom and grow primarily underwater) and emergent (rooted at bottom in shallow areas and grow above water) aquatic vegetation can interfere with fishing, they usually aren't a detriment to the fishery; therefore, complete elimination is not necessary. Although grass carp (vegetation eating carp) can be used to control submergent vegetation, they can cause major water quality problems for the fishery if overstocked or they may not provide the desired results. Several of prior listed fisheries/lake management consultants are also noted as providing aquatic vegetation (including floating and algae species) control services. Contact Game and Parks Fisheries Biologists and discuss vegetation "problem" prior to any type of treatment.

- 8) Numerous aquatic vegetation mechanical cutters and/or harvesters are available – check the internet and YouTube videos. Keep in mind plant fragments remaining in the water from many types of aquatic plants can survive and become a problem again if they are not collected and removed.

Aquatic Vegetation - Algae

Algae can be planktonic (microscopic plants usually suspended in upper few feet and/or on surface of the water - commonly called pea-green soup) or filamentous (usually forms greenish mats upon the water's surface - commonly called pond scum or moss). Death and sickness to pets, livestock, wildlife (especially fish), and even man have been attributed to presence of certain algae/bacteria in water supplies (mostly blue-green bloom-forming species – typically on water's surface and turquoise colored). Several of prior listed fisheries/lake management consultants are also noted as providing aquatic vegetation control. The continuous use of copper sulfate in the same waterbody is detrimental to zooplankton and aquatic insect populations that naturally feed on algae, which can then result in even higher abundances of nuisance algae species. **Don't use copper based products (i.e. copper sulfate, Cutrine Plus, etc.) if trout or Koi are present.** Contact Game and Parks Commission Fisheries Biologists and discuss vegetation problem prior to any type of treatment.
