The spring turkey hunter survey is conducted each year at the end of the spring season. In 2021, the spring season closed on 31 May. The objective of the survey is to obtain information on the spring turkey harvest and success, to determine age and sex of the harvest, and to assess characteristics of the hunt and hunters (e.g., satisfaction). This year's survey was available to hunters from 11-28 June 2021, inclusive. A summary of estimated harvest and success is available in a separate report, *2021 Spring Wild Turkey Harvest*.

Caveats. The spring Wild Turkey Hunter Survey samples spring turkey hunters who provided valid email addresses at the time they purchased their permit(s). As such, the sample frame may be biased and not strictly generalizable to the population of all spring turkey hunters. For the spring 2021 season, however, 76.8% of unique, individual permit buyers provided an email address. A reminder email was sent to all non-respondents one week after the initial invitation was sent, but no further attempts were made to contact hunters who failed to respond to the survey. Therefore, results might be biased toward successful hunters if successful hunters respond more readily to harvest surveys. There is some evidence that responses were biased with respect to residency, sex, and age (see 2021 Spring Wild Turkey Harvest report); residents and men were over-represented among respondents and were older compared to all permit buyers or the survey sample.

Interpretations. Non-resident hunters during the spring 2021 season came largely from Colorado and Minnesota, and residents from Lancaster, Douglas, and Sarpy Counties. Most resident hunters did not hunt in other states (94%), but the majority of non-residents (78%) had hunted in other states, including Kansas and Missouri. Spring 2021 turkey hunters spent an average of 4.85 days afield hunting turkeys. Dawes, Lincoln, and Cass Counties were reported as being hunted in most frequently. Whereas residents were not pursuing a specific subspecies (78%), non-residents reported pursuing Merriam's more than other subspecies (50%). Almost all resident (97%) and non-resident (92%) hunters would hunt Nebraska again based on their experiences in the spring of 2021. In general, most hunters did not think they saw too many hunters, but hunters in the Northwest region may be beginning to see some crowding. Among resident hunters, availability of permits and having family in the state were most important in their decision to hunt in Nebraska. Among non-residents, subspecies available, the number of permits allowed per hunter, and turkey abundance were important.

Take-home Message. Spring turkey hunting continues to be a popular and satisfying experience for turkey hunters. Although crowding is not generally an issue in Nebraska, hunters in the Northwest appeared less comfortable with the number of hunters they encountered compared to other regions.

Methods. This year's survey was composed and administered in-house using Snap Survey development software (Snap v11) and Snap Webhosting service. An initial invitation to participate in the survey for the spring 2021 season was sent to 27,969 permit buyers (76.8% of unique permit buyers), but 708 were bounced back as undeliverable, giving an effective sample size of 20,784 permitted hunters. Initial invitations were emailed on 11 June 2021, and a reminder email was sent to all non-responding hunters on 18 June 2021. The survey was closed on 28 June 2021. The survey was also available on the NGPC website for hunters who did not have valid emails associated with their permits. The website survey was open over the same period as the invitation-only version. At the end of the survey period, responses had been received from 4,972 spring turkey hunters, representing 7,128 individual permits for the spring 2021 season. The raw response rate was, therefore, 18.6% and the permit response rate was 26.8%. Each survey respondent represented 7.4 spring 2021 permit buyers.

Results. Below are figures and tables that summarize hunter responses to survey questions. In most cases, the results are presented for residents, non-residents, and all hunters combined.





Figure 1. Overall rankings of the number of turkeys and hunters seen by respondents during the 2021 spring turkey season.




Overall rating of the number of turkeys and hunters seen





Figure 4. Overall agreement of respondents with statements related to satisfaction with their hunting experiences during the spring 2021 turkey season.





Figure 7. Total number of years of experience hunting turkeys reported by hunters who hunted during the 2021 spring turkey season.




Appendix 1. Unedited text responses from hunters who indicated that they would not hunt in Nebraska again to the question, "Why not?"

Came here to mark another state off for my U.S. Slam. Hunted 1 day in the pine ridge area and had my bird busted by another group of hunters that knew we were set up on said bird. My friends I was with had the exact same thing happen at another location. Eastern Nebraska was very nice with a lot of birds. It was exceptional hunting, however, the state, in general, doesn't possess what I like in turkey hunting. For Rios, Kansas seems to have better hunting at a much lower cost; Marriam's hunting was ridiculous in the pine ridge area and better suited in Wyoming/Montana; and for easterns, I would much rather hunt Missouri/Tennessee/Kentucky. The state has a lot of turkeys with ample public land, but as for me returning, if I ever do, it will be years down the road. I am appreciative for the opportunity though and had a wonderful time.

Hunting pressure was the worst I have ever seen, and I have hunted 12 different states. Fellow hunters were generally very inconsiderate, and the WMA I hunted (Medicine Creek) was far too small to sustain that kind of pressure.

Possibly but I will be more educated about things before I do.

Low bird numbers. Low public land access.

Turkey population seems to be way down in the NW corner while the hunting pressure is abundant.

Too many hunters in the pine ridge area. I saw trucks from 20 different states. In 5 days of hunting I walked over 100 miles and never had a bird reply to my calls even when I was within 150 yds of them. The birds are there but they are extremely pressured and won't respond to calling.

Waaaaaaay to much pressure. Local land owners told the numbers are not what yall are pushing.

I am working to harvest a wild turkey in every state. I have now done that in Nebraska and do not need to return.

too many hunters

While try other states and species. Great experience in NE.

Atleast not for a couple years. Or if I gain permission on private land.

More hunters than turkeys. Way too much pressure on the birds. Worst turkey hunt I've ever had.

Overload of hunters

Cost to high for licenses and poor numbers of game

Not many turkeys and a lot of hunters on a small amount of public land all over the state just kind of made the hunt difficult I would say that I'm an avid hunter and still could not get within 100 yards of these super pressured turkeys

A great deal of time and effort was put into the week of hunting and VERY few birds were seen. It would be much better if there was more public land across the state rather than most in the NW corner. There were no turkeys seen anywhere across the state on our way back home but once back in WI there were turkeys in fields all along the roads. In other words there are not many turkeys in Nebraska. Give out less permits and improve the hunt.

Too many hunters, too few birds left after 1st half of season

Got my merriam

I typically hunt public lands, and the blocks of public land in the southeast portion of the state are not big enough to hunt effectively.

Too many hunters not enough birds

I specialize in late-season hunting and am very successful hunting Eastern gobblers in Arkansas. I hunted very hard in Nebraska. I covered a LOT of ground and explored a lot of habitat on public and private ground. I finally called up a gobbler that I did not kill on May 15, in Custer County. It's a significant investment of time and money to travel so far to a place where the number of gobblers and amount of gobbling is so-so.

If I hunted NE turkey again, I'd try other areas in hopes of less pressure. I'd likely try other states for Merriam.

Too many hunters

Too much pressure for such small number of birds. Seem to have been over hunted based on talking with other hunters I met and other hunters in my group that have hunted Nebraska for 20+ years.

Not enough birds to travel the distance from TN. I've purchased four Nebraska Turkey Permits and have only harvested one bird. I've harvested 57 birds in Tennessee since 2012. I'm also a disabled veteran and the price of permits is too expensive. There needs to be a cost break for disabled veterans that have served our country

Too few turkeys on the open access ground for the number of hunters.

Too many hunters on all the public land we hunted. Turkeys were spooked and would run from a call. Was invited by a close friend who hunts Nebraska every year with great success and he said it was way, way more hunters than he had ever seen.

The number of turkey seen has greatly reduced in and around Chadron (National Forest) over the last few years. We only saw 1 turkey in 4 full days of hunting. (Group of 4 hunters).

The birds just weren't around.

Turkey numbers are WAY down, and the cost per tag is now prohibitive.

All birds were on private land not public

Initially planned on hunting public but the WMA was very pressured with hunters at every access point. I was fortunate to obtain permission from a land owner but heard few birds overall and was lucky to harvest the bird I did get.

Not worth the time and money

So few Turkeys, local land owners I have hunted on in the past, were not willing to allow hunting this year. Nebraska has to cut back on number of permits allowed.

To many hunters for the available birds on public lands. It would be nice to go back to a one Tom limit in the North west corner of the state.

I realize I was there in May but there were very few birds in the areas I hunted, heard very little gobbling and saw very few birds even riding around the county I hunted in.

Didn't see enough turkeys to brin me back

It appeared that wildfires had destroyed too much habitat. There were very few birds to be found. The turkeys we were finding were mostly on private land. It was too accessible by vehicle so it was difficult to get away from other hunters even though there weren't that many hunters compared to the acreage available. I think limited turkey habitat and it being late season resulted in poor hunting. Not a bad place to hunt, but just too many better places to hunt to come back again.

Too many hunters.

Killed a merriam. Completed Grand Slam. Too far away.

Over marketed and too little public land. One landowner said there was a lot of road hunting going on.

Not enough turkeys. Limited public land. Overpressured birds

Way too many hunters. We consistently hiked miles away from roads and had other hunters walk through our set ups. 4 days in a row. All in different areas

Public land too concentrated in pine ridge, bird numbers vs hunters hunting here too low. Please reduce # of birds allowed in pine ridge - even if state quota stays same - pine ridge bag limit is too aggressive

Too far away and a bit costly to harvest no bird

Alot of money for someone like me to spend to not even get on a bird much less hear one gobble....

Too far for not enough turkeys

Might consider a different location. The location we hunted seemed to have been over hunted by the time we arrived...or their just aren't any birds there. Was pretty rough trying to find birds.

Bird population where I have permission to hunt has been declining drastically over the last few years. Not even seeing very many birds.

I would hunt Nebraska again, but not with the same outfitter that I used on this trip.

Area burned out. No birds.

Saw many fewer turkeys than in the previous 10 years. Sad.

Too little public land, too many hunters, too few birds by middle season

There should be a maybe in this question. Maybe i would hunt in a earlier season.

To much pressure from other hunters.

Far to travel

Trying for super slam

Turkey population has been getting worse the past few years there is to many people killing to many turkeys now ! Lower the limit and lower the length of season

Price of tags for non residents.

Drive is long and second tags are to high in cost especially for archery.

Take the time and travel to a new location

I have traveled a lot the last 15 years hunting Thayer and Jefferson counties. There has been a steady decline in the population over the last 5-7 years maybe more. I know there is more hunters nowadays but limits of 3 birds seems absurd. The price increase each year with no change in helping maintain population is also disheartening. I also don't understand why turkey in Nebraska can be hunted almost 8 months out of the year, with fall season harvest being either sex (no beards required). Doesn't seem like the state is taking action like all the other states that have dealt with decline. Therefore I will spend my money elsewhere.

Lack of access

Was my last hunting , age and health

The price is way too high for one turkey...and there are better states to hunt now, even though a bit further away.

Population numbers seemed down compared to previous spring seasons and compared to last fall. Pressure was high as expected but the number of hunters with a blatant lack of respect for others made for a frustrating experience.

Too many hunters and not enough turkeys. I've hunted neb for a lot of years not any more.

Birds too heavily hunted.

Low number of birds:

Too many hunters and not enough turkeys

Way too many hunters. Extremely disappointed in how the state was marketed to non-res hunters. Would suggest a draw AND a season limit of one for non-res license. Have no plans or desire to ever hunt the state again

It's too crowded now

Hunter density at Harry Strunk is too high, I've hunted there before and have been successful and not successful. However, this time I noticed there's VERY few birds in comparison to years past. Turkeys need to be managed better on all public lands in Nebraska and I wouldn't mind seeing a harvest quota or tag quota for the area. The bird numbers just aren't there anymore and if you want to keep the reputation as one of the best turkey hunting states in the nation you need to do better. I wasn't selfish and didn't over hunt or over harvest the area and only killed one bird because of it. If I would've known numbers were that bad down there I wouldn't have even bothered hunting.

Ticks were horrible. Too many hunters for public hunting areas.

Number of turkeys way down compared to previous years never even saw a single male turkey in 5 days and we hunted from sun up to sun down. Also saw way more hunters than i have in last 5 yrs. My opinion over advertised too many hunters now and numbers of birds have s ignificant pleasely dropped last 2 yrs. We will be hunting kansas next year because of the amount of public land available. Hoping to get away from people.

Way to much hunting pressure on public land

Too many hunters. You have over sold your product!!!

Way to many people hunting on public lands, borderline dangerous. On multiple occasions saw people chase them down on the road and jump out and start shooting them

Not enough birds and to many people.

tired of hunting same grounds and the effort to hunt,. I fly from SC, drive 4 hours from Omaha, hunt two 1/2 days, drive back to Omaha and the flights coming and going are very early. I return home exhausted. If more Toms, I would come again.

Not enough birds and too many hunters.

Saw 1 mature bird Tom on public land. Tried multiple times to contact a biologist, game warden or anyone at NE game and parks and 0 people returned my call. I started calling months in advanced because of COVID. Even tried the NWTF person to only get multiple callbacks. I work for the public sector here in AL and it should be a disgrace for the person in charge of this department. The landowner we rented a house from even apologized for his state's government lack of response. He went as far as saying we could come back and stay at his rental house for free next year and I said I won't be returning but thanks for the offer. Horribly run state department.

Too many hunters on too small tracts of public land

Need more public access.

Harvested my bird, moving on toward my super slam

I wanted a Merriam and there were very few available in an area that should have had plenty of birds. You need to reduce the number of birds allowed until the population recovers. If you don't, you won't have any birds left to hunt.

Distance. Likely a one-time trip to hunt Merriams with my son.

Like to try another area

Way too many hunters for the available public land.

Because govener shut turkey season down ,because of covid and I lost 1200.00 to outfitter because of this.

I'll try other states before I come back. I don't believe the number of birds lived up to what was portrayed in your advertising.

Not enough places to hunt

Was specifically hunting Merriam turkey and was able to fill tag on first trip.

It's just far to travel for me.

Not on public land numbers down and seems hinting pressure was high.

Health reasons , getting to old to chase this grand bird

Permits have gotten way too expensive. Taking advantage of non resident hunters

To many hunter and not the turkey population you make it out to be . We still have a good time but the turkeys but it's not a good state to turkey hunt in for my group .

Long drive, few turkeys, heard zero gobbles

You have promoted turkey hunting so much that you have lost the quality of hunting turkey in Nebraska. I came over later in the season thinking there be less pressure. Every spot I hunted had hunters. Very disappointing. I have hunted turkeys for 43 years and this had to be the disappointing state I've hunted in. I never seen so many hunters.

Not enough public ground and no Ranching for wildlife/block management like other states near by. I'll stay in Colorado or go to Kansas or head north.

Too far

Too far from Florida. And flying with hunting equipment (gun and bow) is a hassle

Virtually all of the turkeys had moved to private land. In the future, I will be forced to hunt on private land to be successful. Way too many hunters.

My mother and I have gone out four times in two years counting my mom and I with our bows and have yet to harvest a turkey. Even paid a guide. Had two chances out of the four times but couldn't get one with the bow.

They need a chance to re-populate. There is 1/10 of the bird numbers or less on my case county farm, I found the same thing when I went out to Dunning near the National Forrest.

Bird numbers too low, hunter numbers too high

Low turkey numbers and high hunter numbers on public ground! Not worth it anymore.

Passed thru many states with better hunting.

Farm sold where I was hunting.

Did not see any turkeys or any sign. Will not hunt again until the population increases.

The numbers are so low. On the stretch of creek we hunt there used to be over a hundred birds in a 3 mile stretch. There was 1 Tom, 3 Jake's, and 7 hens there this year. It has been rapidly declining the last few years. Something needs to change or we will soon have no turkeys.

This state is a joke when it comes to hunting. We pay out the ass for permits. And have very little access to land. I will never hunt in this state again.

Because there are no turkeys in my area anymore. Stop giving out so many permits per person

To many hunters

too old

It's just too far to drive from Arkansas. The only reason we hunted Nebraska was because we traded a duck hunt (in Arkansas) for a turkey hunt (in Salina, KS). Nebraska was too close not to turkey hunt so my son and I hunted Nebraska. Everyone we spoke to about getting permission was very friendly and didn't care if we hunted in their property. Our strategy was to drive around until we saw turkeys and then knock on doors or farm shops and ask permission.

NGP due paid hunting and outfitters buying up all leases on private land . Public land being over hunted by out of state hunters. This is the same issue with all species and especially big game species. As it stands now if things keep going the way they are in the state Hunting will be the privilege of the rich. Twenty years ago I could 90 percent of private property just by asking. Not so anymore same land owners but outfits by up the leases and often times never use the land to hunt just to keep other hunters off of it. Its not the land owner to blame with property tax being what they are it just part of survival. I hold your Organization responsible for turning what was a family recreation and legacy in to the Sport of the rich and elite. This has been done through promoting out of state use of our wildlife resources. In order to bring more money in. I understand the money part. When my children were in school 80% of the boys and some of the girls we're hunters. Now with my grandchildren it is closer to 20% are hunting. If you have nowhere to hunt or shoot One of the greatest things about the state will perish. I believe you need a new mindset.

Population too low

Lack of turkeys

Out of staters shot small Tom's, and the already declined turkey population due to overpopulated raccoons. Custer, Hall and Buffalo counties that I farm and or hunt the Turkey populations are way way down and Raccoons are everywhere the out-of-staters just want to fill there tags and don't care about letting them grow. It was very very disappointing to see the turkey numbers so low! Farming/hunting along the Platte River and hunting in Custer county so far this year my estimate is the Turkey population is 1/3 what it was last year! I am VERY VERY concerned! Plus it does not look like the fur market is going to help thin the raccoons. If you have any questions here is my # (402) 705-0074 Chad Wagoner

I would much rather hunter deer. This was my first year hunting turkey and it just was as exciting to me a deer season

Cost of permit.

Not enough birds. Expense of travel and lodging. Tag price high.

Turkey population in Holt and Boyd counties is declining at an rapid rate WHY?

it's too far to travel to hunt turkeys. Also, I was disappointed that Nebraska did not give out of state seniors a discounted price on the permit. In PA and other eastern states, seniors, both in and out of state, receive a discounted price on a senior hunting license.

I was told Nebraska had lots of turkeys and was very disappointed. The state needs to cut the number of tags a hunter gets especially residents in the fall so the numbers will come back.

State employees that I talked to prior to our trip to Gilbert Baker WMA did not mention the extensive wildlife restoration work currently in progress before and during our stay. I talked to a game warden specifically about Gilbert Baker, when we were going to be there and for how long. I believe he should have known about the work being done and advised me to try another area. The heavy machinery, chain saws and workers had an impact on the number of turkeys we encountered. We had a group of 3 over 3 full days hunting and no encounters or even signs indicating turkeys were in the area. The primitive camp sites were great and we had a good time camping!! After 3 days we headed east hunting near Valentine and O'Neil. Thanks for the survey!

Since I was lucky enough to harvest a nice Meriam bird I will concentrate on Rio and Osceola next. I will primarily hunt my home state going forward.

Permits are to expensive. Lack of birds and lack of hunting land

Too many people

Too much hunting pressure

This was a special trip to take grandkids turkey hunting. Probably won't do it again

I have hunted turkeys nearly 20 years. This was the worst year I've ever had hunting. By area has been over taken by walk in hunting lands and the birds are non existent due to this. Public access has ruined the hunting all together in my area. Deer and turkey hunting is complete junk. Will be looking to hunt other areas of the state moving forward.

Permit fee too high for odds of success.

Will most likely go to another state to hunt turkeys. The amount of public land that we have access, to the number of hunters that hunt those lands is just to many. Our public lands are over hunted. Our Turkey population is way down. So unfortunately, if you dont have money you will not get onto private land anymore. Its sad that this sport that I love so much has come to; how much money do you have. And alot of it, is out of state hunting clubs being able to lease land to sell hunts. Since a majority of our tags are OTC, if people dont get a tag in other states that require a draw they just come to Nebraska. I'm glad elk and antelope are still for residents for the most part. But I'm sure that will change as well. The more money that can be made let's do it seems to be the motto for our Nebraksa Game and Parks.

Nebraska advertised as turkey hunting destination state. Everyone coming to hunt turkeys and deer.

Bird density was too low and hunter numbers too high

Plan on hunting a few new states each year

WAY TOOOOOOOOOO MANY hunters in the pine ridge area!! We hunted the area for 4 days and counted plates from 25 other states!!!!!! That alone will cause me to look for other areas to hunt turkeys!! Completely unacceptable!!

During our 3 day trip we only see 5 toms and approximately 15 hens and no jakes. Ten years ago we would 100 birds a day on the same farms and now we saw 20 birds over three days. If something does not change there won't be birds to hunt.

Not worth the effort. Permit cost too high for a single bird.

Not in that part of state

Population has dropped notably since we started hunting fifteen years ago. A noticeable increase in predators: coyotes, raccoon and bobcats, also turkey vultures. Noticed Kansas hunters in most public areas and at times they lowered fence gates and drove in to walk in only land.

To many people social media ruined it

It was once a lifetime experience for me

Nebraska for its size has the least public hunting land

I have better hunting in the Black Hills SD.

It's not likely at this time. It was a nice experience but most all the huntable birds were seen on private land and access was not granted. I may hunt again in Nebraska some day but it would be in a different area with more accessible public and private land. The scenery and camping experience was enjoyable though.

Not enough birds on public land and to many hunters per acre

Hunted in 2021 based on invite from a friend. I had a good time, but don't care if I hunt again

Too many people Jackass "horn hunter" blew my stand"

Low turkey population. Perhaps turkey season should be canceled for a few years to allow them to possibility repopulate.

This was my 4th year hunting turkeys in Nebraska . The first 3 years were great , plenty of turkeys and I didn't run into a lot of hunters . This year , few turkeys and a lot of hunters . i was surprised when I went for the archery opening and ran into hunters on every public hunting area . I have some friends that shotgun hunted that had the same experience . I came back the last week of season to find hunters everywhere I went . I believe the birds had been chased off the public ground due to the hunting pressure. I might return if I can get a land owners permission to hunt . I enjoyed the area , the people and game wardens were friendly .

Public land is too far away from York

Not near the turkey population the state claims to have.

The numbers are extremely low. In addition to hunting there I guided for 6 weeks and saw SIXTEEN bobcats during daylight hours, two attacking dead birds or decoys. Also we found lesions on the heads of some birds and tumor filled livers, which indicates viral disease. Between these two issues I will be surprised if there will be huntable numbers in the coming years, especially with the liberal limits. In my opinion investigations should begin immediately into season length modifications and harvest cutbacks.

The price of a resident turkey tag is ridiculous.

I hunted with Gobble n Grunt outfitters and it was a bad experience. Did not see a lot of turkeys on the land they had leased or on any other land. Maybe other areas of Nebraska has better numbers. It was my first time hunting in Nebraska so maybe I should give it another shot when I get the bad taste out of my mouth from the last hunt. Nebraska is a beautiful state and I will come back to do some upland bird hunting.

To many people

I may do it again, but definitely not during late season. The turkeys were completely done breeding.

The trip was a graduation present to my niece. 3 of us hunted 3 days from daylight to dark, never even came close to working or harvesting a bird. Extremely disappointed. Personally it appears Nebraska has a predator problem.

Not enough turkeys

I saw several turkeys on private land while driving, but the number of hunters on public land was tremendous. Hunted Piney Ridge some, but Mainly hunted Gilbert-Baker WMA. I heard less thean a handful of birds the week I hunted and saw 1 hen on public land.

There are too many hunters to start with compared to the number of turkey. I spoke with several locals and they all stated that there are not the number of turkey that are being advertised. Mountain lions are killing them!!

Maybe

Lack of birds by late in season. May try earlier in season and different area.

I did not hunt where I had planned to hunt because of the high number of hunters and the very low number of turkeys being seen. I harvested my turkey on a different place and one I had never been on before but did see turkeys and harvested a bird. Every one we talked to could not explain why they were not seeing turkeys and most said there had been plenty of birds just a few months before. I had hunted Ne. several times before over the years and had enjoyed good experiences there but this year was completely different from my previous times there.

Not enough turkeys

Too many hunters on public land! Too few turkeys on public lands. Too many ticks got on me.

Too many hunters

Not enough timbered public land and too few turkeys on what timbered public land was available. Numbers werenw low. Too many coyotes, raccoons.

Bird numbers were extremely low in my opinion. Hunter numbers were high. I feel that the state of NE needs to evaluate the population and make changes accordingly.

In my opinion the turkey hunting in Nebraska is vastly overhyped in your promotional efforts. In four days of hunting in what should have been prime weather and habitat in the early part of the season, I heard a total of 1 turkey and saw none while actually hunting. I only saw two other birds in miles of scouting. What I did see was way too many hunters for the area. Most every spot scouted had multiple vehicles parked there from many different state. In the many hunters I talked to in the almost week that I was there, only one had shot a bird. I would not come back to hunt public land again.

there is no turkeys on public land

Turkey numbers seem to be dwindling over the past few years. May be time for us to back off and let the population heal up somewhat.

Not enough time off work in the spring

There were too many hunters for the number of turkeys to make it a quality hunt. I will choose somewhere that isn't excessively over hunted next time.

lack of turkeys and places to hunt.

Unless I have access to private land where they seem to flock, I am pretty sure NE turkey is done for me.

Too much pressure and hunters on public land. Very few birds on public land. Seems to be birds on private because its regulated more. You can shoot to many birds which is killing your population. This was my 3rd trip to nebraska with zero shot opportunities. I hunt Missouri and Indiana every year and aways get birds there.

hunted with a guide called balancing arrow outfitters and i was a joke.

Too many hunters in this area. Need more public ground to get spaced out

Over the last 5 years, the numbers of turkeys has declined dramatically in Nebraska. Not sure of the reason but the population is dropping and there simply just aren't the numbers there used to be. I feel the Game and Parks is not "coming forth" with the reason and unfortunately still allowing 3 birds to be taken on a rapidly declining population. Is it greed or total disregard for the species, I doubt it is either but as a long time resident of Nebraska and now a long time non-resident hunter, I am disappointed with the handling of this game bird.

No turkeys on public ground!

Is really a maybe. Didn't have a good hunt. Heard several but couldn't get them to work. Best chance was blown by another hunter.

Too many hunters, not as much of a quality hunt as it used to be. I have been going to that area (Fort Robinson State Park) for 21 years. This year my have been my last because its over populated with hunters.

I forgave you for your ridiculous 2020 COVID response (stopped selling tags). This year you burned the area I was hunting on the last day of April??? Who does that? I was actually concerned about my safety and equipment at one point. You guys aren't really in it for conservation - more about revenue...

I believe I was fortunate in the area I hunted to not deal with much other hunting pressure. Overall I think Nebraska is highly pressured and a place many out of state hunters will visit to shoot their three birds. I don't want to be apart of the problem so for the time being I will hunt other states to help even if it is only sacrificing my 3 birds I could potentially harvest. I just feel like that is me doing my part for the state of Nebraska.

Will have to think about returning. Too many hunters and not many turkeys due to pressure on them.

Bird count was way too low with pressure and high cost for out of state

To many hunters, not enough open land for recreation

hunting quality is not what it was 10 years ago.

Hunted Bessey forest most of the time. Near zero bird sightings. Too many hunters.

Outfitter was not honest about the number of turkeys he harvests. Outfitter did not allow me to hunt the last 2 hours of the day

to far away

Barely seen any turkeys for that long of a drive

I will not hunt in that area for sure. Population of turkeys were way down. The bird I killed was not in good shape, only weighed about 18 pounds and typically would have been 22-24 pounds. Not sure but I assume the extreme cold weather this year had an impact. The overall gobbling activity was very low. Not the normal turkey hunting in Nebraska.

Unfortunately I had hunters walk in on my hunts every weekend I hunted. I understand that it's public land - but unfortunate to pay so much for a tag and travel and fuel etc - and have guys come in and spook my turkeys every hunt I was on. My sentiment may be different had the folks been more polite but thats the future of hunting in Nebraska I suppose.

After many years of turkey hunting Nebraska, with great success, the number of birds is so low it is not worth hunting there. We literally went from seeing hundreds of birds to not seeing one bird. Seems a consistent opinion from most we spoke too. Not sure why numbers have crumbled, but they are not there.

to many hunters to few turkeys .turkeys didnt gobbel due high presure on them. hunted lake endures area will not go back there..

Tags are too expensive, too many turkey hunters, and poor camping availability/services on public hunting areas.

Have allready killed all species.

The Turkey population in Nebraska is getting worse every year while the hunters are increasing

waste of money, no turkeys to harvest, i can sit in the woods for free

Will try some other states before returning to Nebraska.

Turkeys seam to be on private land

The price of a tag, I did not see many turkeys, the amount of hunters was very high

Sucks

Too many other States to experience before I die.

Have not harvested a turkey in two years during Nebraska hunt

The public hunting area were heavily hunted and turkey's were displaced

Almost all the birds we saw were on private land

Not very good public land management very thick no open areas birds all on agriculture spots on private. I know I was hunting the last week but the birds I saw not many where still doing there thing.

I personally feel as though the management system for turkeys in the state of Nebraska is very poor. i saw very very few turkeys while i was there and the many many hunters i spoke to talked about how bad it's been over the last 10 or so years and that's it's not been improving just steadily getting worse.

Outfitters had all the land locked up and were charging outrageous fees.

Two seasons without even seeing a strutting tom during the hunt and zero harvest opportunities does not encourage me to hunt this place again.

Too many people. Way overhunted. 3 over the counter tags sounds all great but in reality that's doing nothing but hurting the Turkey population on public land. The few birds I did see wouldn't respond due to over pressured. Would come and run the opposite way once they see a decoy. Campgrounds were packed with hunters, the public land was worse. Limit it back to 2 birds, if not one. Otherwise make it one bird a week allowed, 2 birds max per season would be best.

Almost all the birds seen on the trip save two were on private land.

Too many hunters in woods at same time. Earlier time periods birds were all on private adjoining land and no one will give permission. Birds were split up more later season however. I would personally recommend splitting full season like Wisconsin does into 6 or 7 separate weeks n give the hunters flexibility to choose which 2 time periods they want to hunt. Spread hunting pressure out more

NE charges too much for a turkey tag with too little access to good hunting habit. What habitat that is available has entirely too many hunters utilizing it. Also it is what \$163.00 for one non resident turkey tag? You should discount additional tags though I haven't had a need to buy more than one. I've turkey hunted the last 15-20 years in Kansas and have harvested a turkey every year. I have hunted NE twice in the last 5 years and have not fired a shot. NE should provide more access to private land via a walk in hunting program. As it is, it really isn't worth the time and expense to hunt turkeys in NE in my opinion.

The turkey population in your state is decreasing. You need to restrict the number of birds you can harvest. I know several people who are coming up there and killing three birds each. They've been doing this for several years and it's starting to become apparent. I'm not coming back up there to hunt until the population rebounds.

Only because I like to hunt different states

The last time I hunted I saw close to a 100. Population on public ground does not exist anymore. I work with several people who turkey hunt that don't hunt them anymore because they can't find any.

I think based on my observations and the response of turkeys accross the US where I hunted there is a severe decline in Vocalization and it turkey numbers. I am concerned of the decline and am not sure if it's due to hunters, predators, or poor habitat. With the vast majority of CRP ground going back into crop fields I have realized that the loss of cover has been devastating to both deer and turkeys. I once thought it would improve numbers with the additional food sources but I was never so wrong. There was adequate food all along and more cover. Browse and native grasses along with lots of bugs are what turkeys need combined with cover and nesting sites. I'm no biologist but I've been hunting since I was 8 and I'm 55 now. I've hunted all over this country and I promise you something is going on with turkeys not just in your state but all over. I'm concerned we are opening the season to early across the country and allowing to many birds to be harvested. I can't really speak to Nebraska that was my only trip there.
