2021 Nebraska Draw Results

General Bull Elk

In 2021, 5,254 Nebraska residents submitted 5,102 applications (152 buddy applications) for 150 bull elk permits. This was a 7% increase in applications over 2020. 431 individuals purchased elk bonus points.

Bull elk drawing data were calculated using First Choice options only. High demand units are represented with the most accuracy as 95% of awarded permits were from First Choice options. See Table 6 for breakdown of First and Second Choice distribution.
