2024 Free-earned Landowner Elk Harvest Reporting Form

Form must be received by 5 p.m. Feb. 16, 2024, at Nebraska Game and Parks

RULES:

- 1. Following the verification of 10 general antlerless or depredation season elk harvests, a qualifying landowner who owns or leases at least 80 acres of agricultural land or their immediate family shall qualify for an either sex elk permit. The free-earned permit must be designated to the qualifying landowner or their immediate family on a form provided to the landowner by the Commission by the last Friday in March. Harvest will be limited to 1 elk of either sex and is limited to the lands owned or leased by the qualifying landowner during any open elk season provided weapons legal for that season are used. Only antlerless elk may be taken during antlerless-only seasons. The permit must be designated for the next elk season following the 10th qualifying antlerless harvest.
- 2. Immediate family includes the landowner's spouse, child, stepchild, spouse of child or stepchild, sibling sharing ownership or spouse of sibling.
- 3. Qualifying farm and ranchland **MUST** be used for agricultural purposes such as crop or livestock production. Land used solely for recreation does **NOT** qualify. **Hunting leases do not qualify.**
- 4. The number of antlerless elk harvested to qualify accumulates each year until such time as a free-earned landowner elk permit is awarded. It is unlawful to falsely report antlerless harvests.
- 5. Only general antierless or depredation season harvests are eligible. Antierless elk harvested on landowner elk permits are not eligible for this program. Only harvests that occur during the most recent early- and late-antierless season will be allowed on the form. Special depredation season antierless harvests will be recorded within one month of the close of the elk season.
- 6. Owners or leaseholders applying for the free-earned elk permit are **NOT** required to live in a Landowner Elk Zone.
- 7. Important Dates:
 - a. Harvest Reporting Form (this form) Due: Third Friday in February (2/16/2024)
 - b. Permit Designation Form Due: Last Friday in March (3/29/2024)
- 8. Forms must be submitted to the Nebraska Game and Parks Commission District Wildlife Office which has authority for the elk management unit listed on the application form set out below:
