Title of Job: 2025 Spring Wild Turkey Success and Harvest

The Nebraska spring wild turkey hunter survey is conducted each year at the end of the spring season by email. The season opened 25 March 2025 and closed on 31 May 2025. The objective of the survey is to obtain information on estimated spring turkey harvest and success. Information on age and sex composition of the harvest is also obtained. This year's survey was available to hunters from 16 June 2025 until 1 July 2025.

Caveats. For the spring 2025 season, 94.5% of unique permits sold were associated with an email address, and as such, the sample frame was representative of the population of permit buyers. A reminder email was sent to all non-respondents one week after the initial invitation was sent, but no further attempts were made to contact hunters who failed to respond to the survey. This yielded a hunter response rate of 22.9% and permit response rate of 30.6%. These response rates, compounded with the potential bias of successful hunters more readily responding to surveys, may inflate success and other estimates. Regulation changes implemented in spring 2023 reduced the number of permits hunters could purchase per season and put a quota of 10,000 on nonresident permits. Therefore, changes in permit sales observed in 2024 and 2025 were likely impacted by these regulation changes and do not reflect changes in the permit-buying behavior of spring turkey hunters. Likewise, the reduction in available permits may have reduced total harvest in 2024 and 2025.

Interpretations. Youth permits continue to be a strong component of overall spring permit sales, comprising 14.3% of the total permits sold for the spring 2025 season. Spring 2025 harvest was 17.8% higher than spring 2024 harvest (11,941), with an estimated total harvest of 14,068 turkeys in 2025. Overall harvest success was 52.7% compared to 46.7% for spring 2024 and 48.8% for spring 2023. Spring 2025 success rates were above the management goal for spring harvest success of 50%.

**Take-home Message**. Spring turkey hunters continue to enjoy modest success in Nebraska. The decrease in the number of permits sold and in total harvest compared to pre-2023 can be partially attributed to the reduction in the number of permits a hunter could purchase and the establishment of a quota for nonresident permits. For those spring hunters who went afield, success was greater than the 50% goal established by the Focus on the Future plan.

**Methods**. This year's survey was composed and administered in-house using Snap Survey development software (Snap v11) and Snap Webhosting service. An initial email invitation to participate in the survey for the spring 2025 season was sent to all permit buyers with an email on file, resulting in 19,727 survey invitations (92.1% of unique permit buyers). However, 493 bounced back as undeliverable, giving an effective sample size of 19,234 hunters. Initial invitations were emailed on 16 June 2025, and a reminder email was sent to all non-responding hunters on 24 June 2025. The survey was closed on 1 July 2025. Because nearly all permitted hunters provided an email address, no standalone version was available on the agency website for this year's survey—a standalone version was last utilized in 2022.

**Results**. At the end of the survey period, responses had been received from 4,405 spring turkey hunters, representing 5,884 individual permits for the spring 2025 season. This yielded a raw response rate of 22.9% and a permit response rate of 30.6%. Each survey respondent represents




**FIGURE 4**. Estimated spring turkey hunter success rate per permit, 1964-2025. The black horizontal line represents the success-rate goal of 50% established in the Focus on the Future plan. The dotted gray line represents regulation changes implemented in 2023.

4.86 unique spring 2025 permit buyers. Permit sales for the spring 2025 season (n =26,691) were 4.3% higher than spring 2024 sales (n = 25,581; Figure 2). Of all permits sold, 3,828 (14.3%) were youth permits and 22,863 (85.7%) were statewide regular and landowner permits. Of all unique permit buyers (n = 21,417), 80.2% bought only one permit and 19.8% bought two permits. From the information provided by survey respondents, the estimated total turkey harvest for the spring 2025 season was 14,068 turkeys. Of these, an estimated 1,718 were harvested on youth permits and an estimated 12,350 were harvested on regular statewide permits (Table 16, Figure 3). The total estimated harvest of spring 2025 was 17.81% higher than that of spring 2024 (n=11,941). Overall success during the spring 2025 season was 52.7% compared to 46.7% in 2024 and 48.8% in 2023. Youth success increased to 44.8% and regular/landowner permit holders' success was higher at 54.0% (Table 15, Figure 4).









**FIGURE 3**. Estimated spring turkey harvest, 1964-2025. The dotted gray line represents regulation changes implemented in 2023.

Turkey population seemed low. And although I didn't see a ton of hunter pressure you can tell birds were pretty pressured because they were all pushed to adjacent private ground.

I will only hunt deer.

Less permits available

Not enough birds

Not worth all the time plus i just give the birds away

Bird numbers are so bad-I mean it's actually quite sad. Nebraska has gone downhill substantially in the last 5 years. It's just not really worth the time.

Turkey population is way down especially for not seeing many turkeys during youth opening weekend

Waste of money since there isn't enough hunting space

Minimal turkeys on public lands, not enough roosting capabilities for Merriams

I was fortunate to fill my tag early in the archery only season. I went back with a friend that had a tag in late April into May. During that time, there were a lot of hunters, mostly non-residents like myself. It wasn't too crowded but definitely a limiting factor.

#### I shot my Merriams

There are 2 big issues: 1. the quantity of birds have significantly decreased. In areas like Chadron, I used to see 3x to 5x the amount of birds. Your studies have also shown this. This year, for the multiple hunting parties I joined, bird sightings were at an all time low. 2. A huge area with incredible quality in the wild-cat hills (Scottsbluff) has all burned down. The habitat loss is significant. There were fires in Chadron too. I get it, most turkey hunters in Nebraska have their farm and it's easy. But for non-residents, especially coming from Colorado where there is public land everywhere, it's pretty crazy how little HUNTABLE public land is left in NE (pan-handle area). I used to see a lot of non-resident turkey hunters in the wild-cat hills. It finally hit a point where I see more turkeys in colorado than I do in NE. 10+ years ago, it was worth the price (license, travel, etc) because there was good habitat and you were near guaranteed to see birds. At the big price increase, with little habitat and low bird populations, it's just not worth it.

The private land I hunt was sold

Been there, done that. Time to move on and experience a different state.

Permit is too expensive. Turkey numbers are too low.

Numbers are down, no turkeys.

There's not enough public land and the turkey numbers are too low. I hunted hard 9-10 days and didn't even see one gobbler on public land. I only heard one gobble, and I think it was a jake which I don't shoot.
